



## **INFORMATION ON THE PROCESSING OF PERSONAL DATA**

### **pursuant to and for the purposes of EU Regulation 2016/679 and of the national privacy legislation**

This information is provided pursuant to and for the purposes of national and European legislation regarding the protection of personal data (meaning the EU Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 concerning the protection of individuals with regard to the processing of personal data, as well as the free circulation of such data and the legislation on the protection of personal data applied in Italy, including the provisions of the Guarantor).

O.V.S. S.p.A., with registered office at Via 5 Martiri, 33 - 24029 Vertova (BG) Italy - as data Controller - collects and processes your personal data in compliance with the provisions of the current privacy legislation.

The Company is required to provide certain information regarding the processing of your personal data in relation to the purposes indicated below.

Your personal data will be processed by computerized and non-electronic means and with the adoption of technical and organizational measures aimed at guaranteeing a level of security adequate to the level of risk.

### **1. Purpose of the processing**

Your personal data will be processed in full compliance with the obligations and principles set forth in the aforementioned legislation in force for:

- a) the execution of the obligations deriving from the contractual relationship possibly entered into with the company; the fulfillment of administrative, accounting and tax obligations (management / processing of orders, correspondence, invoicing, etc.) connected to the aforementioned contractual relationship; purposes connected with instrumental to the fulfillment of obligations deriving from the current legislation;
- b) sending commercial information and exclusive invitations to events at exhibitions.

### **2. Legal basis of the processing**

The Company will process your personal data in the following legal bases:

- a) You have given your free, specific, informed, unambiguous and express consent to the processing;
- b) The processing is necessary for the execution of a contract of which you are a part;
- c) Processing is necessary to fulfill a legal obligation;
- d) The processing is necessary for the pursuit of the legitimate interest of the Owner.

### **3. Recipients and / or any categories of recipients of personal data**

For the pursuit of the aforementioned purposes and, within the limits strictly pertinent to them, your personal data may be disclosed to the following subjects:



- a) Employees of the Company as well as third parties who, on behalf of the same, carry out specific services or carry out related, instrumental or support activities;
- b) external consultants of the Company located in countries belonging to the EU;
- c) insurance companies, established in countries belonging to the EU with which the Company may enter into contracts or agreements;
- d) any other person to whom personal data must be communicated due to legal or contractual obligations or provisions issued by authorities legitimated to do so by law.

**4. Storage period of personal data**

Your personal data will be stored by the Owner in full compliance with the principles of necessity, minimization, conservation limitation, for a period of time necessary to guarantee the correct fulfillment of the contractual obligations, without prejudice to the need for conservation for a longer period in compliance with the applicable legislation, including tax.

If you have expressed specific consent for the purpose referred to in point 1b), your data will be stored until the aforementioned consent is revoked and, therefore, the marketing activity may be carried out until the revocation of the same.

**5. Rights of the interested party**

In relation to the processing of data, the interested party may exercise the rights provided for by the articles 15-22 of the Regulation (EU) 2016/679, consisting of the right to request access to personal data, the rectification or cancellation of the same, the limitation to processing, the right to oppose the same and possibly, the recurrence of the conditions, in the right to portability, by sending a registered letter to: OVS S.p.A., Via 5 Martiri n. 33, 24029 Vertova (Bg) Italy, attaching a copy of the identification document of the interested party.

If the request is forwarded by a person other than the person concerned, if such person does not provide proof that the request is legitimately made on behalf of the person concerned, the request will be rejected.
